

Assembly, Installation, and Operating Instructions

SAFETY SUMMARY

WARNING

DO NOT install this equipment without first reading and understanding this instruction sheet. If you are unable to understand these instructions, contact a healthcare professional, dealer or technical personnel before attempting to install this equipment - otherwise, injury or damage may occur.

Check all parts for shipping damage. In case of shipping damage, DO NOT use. Contact Carrier/Dealer for further instruction.

Make sure that tray is properly secured to the armrests at ALL times.




FIGURE 1 - INSERTING COMMUNICATION ITEMS INTO COMMUNICATION TRAY

INSERTING COMMUNICATION ITEMS INTO COMMUNICATION TRAY (FIGURE 1)

- 1. Spread the two (2) sections apart and insert communication items between them (**FIGURE 1**).
- For installation, refer to FULL LAP TRAY/ COMMUNICATION INSTALLATION in this Instruction Sheet.




FIGURE 2 -COMMUNICATIONS / FULL LAP TRAY INSTALLATION

COMMUNICATION / FULL LAP TRAY INSTALLATION (FIGURE 2)

- Place the communication or full lap tray over the armrests of the wheelchair.
- 2. Slide the tray in or out for proper position for the end-user.

WARNING

Make sure that tray is properly secured to the armrests at ALL times.

3. Secure the straps around the armrest and attach.

Invacare's sole obligation and your exclusive remedy under this warranty shall be limited to such repair and/or replacement.

For warranty service, please contact the dealer from whom you purchased your Invacare product. In the event you do not receive satisfactory warranty service, please write directly to Invacare at the address on the next page. Provide dealer's name, address, model number, and the date of purchase, indicate nature of the defect and, if the product is serialized, indicate the serial number.

Invacare Corporation will issue a return authorization. The defective unit or parts must be returned for warranty inspection using the serial number, when applicable, as identification within thirty (30) days of return authorization date. DO NOT return products to our factory without our prior consent. C.O.D. shipments will be refused; please prepay shipping charges.

LIMITATIONS AND EXCLUSIONS: THE WARRANTY SHALL NOT APPLY TO PROBLEMS ARISING FROM NOR-MAL WEAR OR FAILURE TO ADHERE TO THE ENCLOSED INSTRUCTIONS.
