# Table Warranty

Hudson Shuffleboards warrants its Shuffleboard table products against defects in material or workmanship (excluding normal wear and tear). Hudson Shuffleboards, at its sole discretion, will either repair or replace any and all parts proven to be defective. Excluded are any products sold or unused for commercial purposes. The warranty is subject only to the limitations set forth below:

- All covenants of this Warranty are non-transferable and only applies to the initial purchaser (owner) of the product from Hudson Shuffleboards or any of our Authorized Agents or Dealers
- Any claim to this warranty must be made through Hudson Shuffleboards or one of our Authorized Agents or Dealers
- Warranty for the Cabinet against any defects are warranted for a period of one year from the date of original purchase
- The electronic score unit proven to be defective is warranted for a period of 60 days
- The playing board has a one year warranty against manufacture defects.  
*Please note that solid wood has characteristics which are beyond the control of the manufacturer. Wood is a natural material, sensitive to environmental humidity. It will move considerable in response to extremes in the surrounding conditions. Wood can expand and contract in response to the particular environment in which they are located. It is important that a stable humidity is maintained in order to insure continued stability. Wood also has naturally occurring variations of color. This is not considered a manufacturing defect*
- The playing surface (polymer) is warranted for the lifetime of original owner.

## Returns and Repairs

- Parts returned hereunder if requested by Customer Service shall be shipped pre-paid by LTL surface freight to Hudson Shuffleboards. If the parts are determined by Hudson Shuffleboards, in its sole-discretion to be defective, they will be repaired or replaced and returned pre-paid by LTL surface freight carrier. The cost of shipping (as provided herein) the product to Hudson Shuffleboards shall be reimbursed as well. The labor cost for removing or replacing the damaged part shall be the responsibility of the owner. If the claim occurs more than one year from the date of the original purchase, shipping costs shall be the responsibility of the owner.
- Repairs or replacement of any defective parts shall constitute complete fulfillment of all obligations with respect to the Product. This Warranty does not require the replacement of the entire Hudson Shuffleboard table. Only the replacement of the defective parts.

## Warranty Limitations

- Any failure caused by abuse, neglect or improper installation, improper use, installation or maintenance service and repair. This warrant does not cover normal wear and tear.
- This warranty does not cover any cabinet finish including scratches, nicks, dings, or cosmetic blemish in the cabinet finish surface.
- This warranty does not cover any shipping damage or damage that may occur during the set up, unpacking or installation process.
- Installation and labor costs to remove or replace the warranty part shall be the responsibility of the original owner
- This warranty does not include commercial use or application of the product.
